Co-hosted UDS 2009-2010 Training

11/20/2009, Omni Austin Hotel Downtown, 700 San Jacinto, Austin, TX
This training will cover the preparation of the 2009 UDS Report. Changes to the UDS editing and submission process, and to several of the tables will be highlighted along with a clear description of the differences between the UDS and BPHC's new ARRA reporting (the HCQR). *This will not however, be an ARRA training program.* It will address each of the tables, integrating a discussion of the changes that have been made and the definitions necessary to complete the reports. Because of wide-spread problems in submitting the new clinical measures tables (Table 6B and 7), these will once again be covered extensively. The training is aimed at those who are responsible for gathering and reporting the data elements included in the UDS report, as well as for management staff who need to understand the definitions and concepts used. The session will be conducted by BPHC's UDS contractor, John Snow, Inc.

Joint Commission National Patient Safety Goals for 2010: The Joint Commission's National Patient Safety Goals (NPSGs) for 2010 were initially announced September 9, 2009, and some of those changes were effective immediately. The Universal Protocol has also been revised and some changes are effective immediately. While no new NPSGs have been developed for 2010, on January 1, 2010, organizations will be expected to have fully implemented the requirements related to health care-associated infections (which were established with the 2009 NPSGs). Adult Safety Net Vaccine Initiative Expansion: We recently sent out information regarding the expansion of the Adult Safety Net Vaccine Initiative. You should have all received information from your local or regional health department by this point. Please let Whitney Monge at wmonge@tachc.org know if you have not yet received this information. As a reminder, the Texas Department of State Health Services has expanded the Adult Safety Net Vaccine Initiative to include all adult vaccines. These vaccines will be provided free of charge to FQHCs. As most of you are aware, DSHS has only been offering adult Hepatitis B containing vaccines since the first expansion of the

CDC project in 2008. The guidelines for participation and eligibility are the same for the expansion of additional vaccines into the program. The additional vaccines include:

- Hepatitis A adult vaccine,
- Human Papillomavirus Vaccine (HPV),
- Measles, Mumps, and Rubella (MMR),
- Meningococcal Conjugate (MCV4),
- Tdap/Td vaccine,
- Varicella Vaccine, and
- Zoster Vaccine
