### **ICD-10 CM Clinician Training**

**October 8th, 8:00 AM-12:00 PM, Westin Galleria Dallas**

Starting October 1, 2015 medical providers will need to be compliant with the new International Classification of Disease (ICD-10) coding system. Compliance means that everyone covered by HIPAA is able to successfully conduct health care transactions using ICD-10 codes. Providers working in medical practices or clinics are may experience difficulty adjusting to the new ICD-10 code sets if not properly trained. **Registration for this training is separate from the TACHC Annual Conference.**
